Promoting SNAP to Benefit your Students and Schools



Introduction

What is SNAP?

SNAP is the Supplemental Nutrition Assistance Program (formerly the Food Stamp Program). SNAP provides nutrition assistance to households with low-incomes. SNAP is a federally funded program, just like the School Breakfast and National School Lunch Programs. The primary objective of SNAP is to reduce hunger and improve the health and wellbeing of individuals and families currently facing food hardship by providing them with benefits to purchase food at grocery stores, retailers, and farmer's markets nationwide.

What is the Connection between SNAP and School Meals?

SNAP eligibility is based on household income. In Connecticut, a household may be eligible if their income is less than 185% of the Federal Poverty Level, the same income threshold that is used to qualify for reduced-price school meals. The added benefit to a household receiving SNAP benefits is that the children are "directly certified," or automatically eligible, for free school meals without having to fill out the Free/Reduced Price School Meal Application. Furthermore, meals served to students directly certified for free meals through this method are claimed at the federal "free" rate – the highest reimbursement level allowable for school meals. Maximizing the number of families receiving SNAP in your school population is a win-win for both families and your school.

Why Promote SNAP through Schools?

More than 425,000 people receive SNAP in Connecticut, yet many eligible households are still not being reached. Some families simply do not know how to apply or are not aware that they may be eligible to receive monthly benefits for food through SNAP. Your school is ideally positioned to spread the word to households and students about SNAP to help address hunger and ensure students will be nourished and ready to learn.

To help you get started with SNAP outreach through your school, templates and resources, as well as suggestions on how to use these to spread the word about this important program for the students and families you serve are included in this toolkit.

EHC! Call Center & Pre-Screener

The EHC! SNAP Call Center is the first of its kind in CT. The Call Center and Pre-Screener allow individuals to prescreen their household for SNAP eligibility online whenever and wherever it is convenient for them. If it appears a household is eligible through the Pre-Screener, they can contact the SNAP Call Center to apply for benefits. Applications for SNAP can be completed over the phone through the call center. The statewide toll-free phone number is staffed by trained specialists, including bilingual Spanish-speaking staff. Call Center associates assist callers through the enrollment process, determine eligibility, fill out the application and submit required documents to the CT Department of Social Services, provide technical support, and advocate for clients when needed.

GET STARTED

The EBT (Electronic Benefits Transfer) card is used by all SNAP households to receive and spend their benefits. With the EBT card the benefits are transferred directly to the card for the recipient to use at the retailer of their choice.

Review the Deduction Checklist to make sure you're receiving the correct benefit amount.


SNAP Postcard

Letter to Parents

Customize this template Letter to Parents about SNAP to send to families through school mailings.

Dear Parents,

We are writing to let you know about a great program that could benefit you, your kids, and our school. Do you, or does a family you know, need a little more flexibility in budgeting for food? If so, the Supplemental Nutrition Assistance Program (SNAP) may be an option. With SNAP, families are able to purchase more groceries and stretch food dollars, school children will automatically qualify for school breakfast and school lunch at no cost and families will be supporting our school by helping us to qualify for more funding.

SNAP is designed to help people in Connecticut supplement their food budget. SNAP benefits are distributed monthly to participants through an Electronic Benefits Transfer (EBT) card. SNAP participants receive an EBT card once their application has been approved and monthly deposits are made to their EBT card. The SNAP EBT card is utilized in the same manner as a debit card and is accepted at grocery stores, most retail stores, and many farmers' markets, or any outlet posting the USDA sign "EBT accepted."

Applying is quick, easy, and confidential. Many families are surprised they qualify! **To see if you are eligible, call End Hunger CT!'s statewide, bilingual (English/Spanish) SNAP Call Center at (866) 974-7627**, open Monday through Friday 9AM-5PM. You may also use the online SNAP pre-screener anytime at www.CTSNAP.org. If you qualify, EHC! advocates can assist you in applying for SNAP benefits through the SNAP Call Center.

Web Button





What is a SNAP Web Button?

A SNAP web button is an image you can add to your website (see above) that promotes the federal Supplemental Nutrition Assistance Program (SNAP). The image is hyperlinked to the SNAP Pre-Screener at www.CTSNAP.org. The Pre-Screener is a confidential online tool that collects household and income information and tells the participant if he/she is eligible for SNAP in Connecticut. Once determined to be eligible, participants are prompted to contact the End Hunger CT! SNAP Call Center to apply.
