# Overview:

The Hunger Free America Summer Associate Program aims to create more food secure families and support nutritious food choices. Summer Associate members will work on one or more of the following:

• Provide education for and increase access to food security resources, including Summer Meals, SNAP, and other local resources by conducting outreach and education to raise awareness about the programs.

## Member Duties:

Activities may include, but are not limited to:

- Contacting and partnering with current and potential farmers' market partners for onboarding and outreach regarding the CT Fresh Match program (EHC!'s SNAP-doubling program at farmers' markets across CT);
- Coordinating & conducting in-person market partner visits and EHC! tabling events on market days;
- Contacting community stakeholders, emergency food providers, & social service agencies to raise awareness of CT Fresh Match for SNAP customers;
- Implementing CT Fresh Match social media outreach and creating/distributing other mediums of outreach materials.

The ideal candidate is interested in hunger issues and local agriculture; has experience working with diverse communities; has a willingness to be flexible and work on all kinds of tasks and projects; has the ability to work both independently and as a member of a team; is reliable; has a good work ethic, organizational, and communications skills. **Program Benefits:**

# End Hunger Connecticut! Specific Duties:

The Anti-Hunger Associate will assist EHC! in promoting EHC!'s CT Fresh Match SNAP-doubling program throughout the summer. They will be responsible for the following duties:

- Coordinate with EHC!'s current market partners to prepare for upcoming market season.
- Manage program website pages and help implement new features on <u>www.endhungerct.org</u> throughout the summer. Some basic coding may be needed, but instruction will be provided.
- Conduct CT Fresh Match market partner site visits throughout the summer. The Anti-Hunger Associate will be responsible for organizing and documenting visits through photos, videos, and interviews with onsite market managers, as well as serving as a representative of End Hunger CT! (instruction will be provided so member feels comfortable and prepared to be an organization representative).
- Lead social media strategies and implementation for CT Fresh Match.
- Collaborate with current and prospective market partners, as well as community organizations/services that serve SNAP households, to coordinate distribution of CT Fresh Match promotional materials throughout Connecticut.
- Complete reporting for Hunger Free America/ AmeriCorps and End Hunger CT!, including documenting activities, maintaining inventory logs for outreach materials, and compiling reports.

- A great attitude and willingness to work on all kinds of projects
- Interest in hunger issues & local agriculture
- Commitment to working with diverse communities
- Dependable, responsible, and has an excellent work ethic
- Good customer service and people skills
